CITB announced that Pearson Vue HS&E test centres would close until further notice from Friday 20th March 2020. This temporary closure will be monitored on a weekly basis.

- Independent Internet Test Centres
  - ITCs are operated by colleges and training providers who have been approved by CITB to provide testing facilities for tests such as the HS&E test.
  - From the info we have from CITB, some ITC's are still accepting bookings but we have no way of being able to identify which ITC's these are and how long this will continue for.
- Candidate support
  - CITB are working closely with Pearson Vue who operate the main network of HS&E test centres to ensure that support is in place to reschedule or refund the candidates test if canceled.
  - CITB are also working with Pearson Vue to explore options that will ensure the capacity of testing centres is maximised when the test centres re-open.

## **CSCS Announcement**

Following the announcement from CITB as above, CSCS released a statement with the main message being as follows:

- CSCS requested that employers and those responsible for site access and card
  checking procedures to use their discretion towards workers whose cards have
  expired since mid-March onward and who can provide evidence that they have
  been unable to sit their test or undertake the required training as a result of
  the closure of the test/training centres.
- They stressed that "this is at the employer's discretion until the situation has stabilised".
